

Powerblast Global Cashback – Carpark Sale – Terms and Conditions

Terms & Conditions Pertaining to the \$200 Cashback at the Powerblast Carpark Sale.

By participating in this cashback ('Promotion'), participants ('Participants') are deemed to agree with these terms and conditions.

Entry is only open to Australian residents aged 16 years or over. Entrants between the ages of 16 and 18 years must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions.

Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion.

The promoter means the legal entity identified in the Powerblast Global privacy policy found at www.powerblast.com.au ('Promoter Privacy Policy' and 'Promoter' respectively).

Employees of the Promoter and agencies associated with the Promotion are ineligible to participate in the Promotion.

The Promotion commences at 08:00am on Saturday 22nd June 2024 and ends at 2:00pm on Saturday 22nd June 2024 ('Promotional Period').

To be eligible to receive the cashback, participants must purchase a pressure washer from Powerblast at the Carpark event (Saturday the 22nd of June 2024) for the value of or greater than \$1,500+gst and have brought in an old pressure washer to trade-in. Trade-In meaning Powerblast has ownership over the old machine through the transaction of the new machine.

One (1) entry is allotted per participant.

The Promotion is on an individual basis with each person having one opportunity for \$200 cashback when trading in an old pressure washer for the duration of the event. (8.00am – 2.00pm Saturday 22nd June 2024)

The cashback is \$200.00 that will be discounted off the invoice of the new machine at or over \$1,500+gst.

The cashback, or any unused portion of the cashback, is not transferable or exchangeable and cannot be taken as cash.

If the winner does not take the Cashback (or an element of the Cashback) by the time stipulated by the Promoter, then the Cashback (or that element of the Cashback) will be forfeited.

The Cashback will be provided to the person named on the invoice.

The receiver should seek independent financial advice related to the Cashback.

All participants become and remain the property of the Promoter. The Promoter may use the Participant's name and entry content for any commercial purpose, including future promotional marketing and publicity purposes.

All personal information about a Participant submitted as part of a transaction will be protected in accordance with the Promoter's Privacy Policy. All Participants who choose to 'opt in' consent to have their contact details released to the Promoter and to receive ongoing marketing material and communications from the Promoter and agencies associated with the Promotion.

If for any reason a winner does not take or claim the Cashback as of 5 days after they have transacted with Powerblast Global, the Promoter may (a) treat the Cashback as forfeited.

The Promoter reserves the right to verify the validity of Participants and their entry.

If for any reason the Promotion is interfered with or is not capable of being conducted as reasonably anticipated due to any reason beyond the control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any Participant, or (b) modify, suspend, terminate or cancel the Promotion.

The Promoter shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to direct or consequential loss) or for any personal injury suffered or sustained in connection with the Cashback, except for any liability which cannot be excluded by law.
